重要通知：消防處展開樓宇消防裝置及設備巡查計劃「前哨行動」

因應近期全港多宗涉及舊式樓宇的火警事故，消防處已於 2026 年 1 月 19 日起展開名為「前哨行動」的大型巡查計劃，目標於兩個月內巡查約 1,500 幢於 1987 年或之前入則的樓宇，重點檢查消防裝置運作狀況及有否違規擺放雜物等情況；如發現違例，將即時執法。

本苑 第 1, 2, 4, 8, 10, 11, 12, 20, 21, 24, 25, 26 座 已接獲消防處正式通知，將對上述座別，包括各樓層公眾位置雜物及消防裝置等作出巡查，而其他座別稍後亦會作出突擊巡查。本部就此呼籲各業戶，為確保大廈符合消防安全要求，敬請各位業戶留意以下事項：

1. **切勿阻塞**任何走火通道、消防門或消防設備；
2. **立即移除**佔用公眾地方(包括大廈樓層設施房間)、走廊等所有雜物，包括：地氈、鞋架、鞋履、儲物箱、單車及地主神位等物品；
3. 消防巡查當日或會進行警鐘鳴響測試，屆時屬正常測試程序，請勿恐慌；
4. **消防處或會於突擊檢查發現違規時，即時票控有關違規單位而不作口頭勸喻。**

敬請各業戶認真配合，多謝合作。

RE : Fire Services Department Inspection Notice

The Fire Services Department has formally notified that inspections **will be carried out** at Blocks **1, 2, 4, 8, 10, 11, 12, 20, 21, 24, 25 and 26** of the Estate. Public areas on all floors, including miscellaneous items and fire service installations, **will be inspected**, and surprise inspections **will be conducted** at the remaining blocks in due course.

Occupants **are reminded** of the following measures to ensure that compliance with fire safety requirements **is maintained**:

1. Any fire escape routes, fire doors, or fire service equipment **must not be obstructed**.
2. All miscellaneous items placed in public areas (including building facility rooms on various floors), corridors, etc., **must be removed immediately**, including carpets, shoe racks, footwear, storage boxes, bicycles, and shrine setups.
3. A fire alarm sounding test may be carried out on the day of inspection. As this is considered part of normal testing procedures, no alarm should be raised.
4. Fixed penalty tickets may be issued immediately by the Fire Services Department during surprise inspections if violations are identified, and no verbal warning will be given.
